TERMS AND CONDITIONS

RULES AND REGULATIONS: The camper ("Camper") and parent(s) agree to abide by all the rules and regulations established by Camp Cedar ("camp") including, without limitation, those relating to enrollment and withdrawal of campers and visitation.

PAYMENT: Payment terms are a \$2000 deposit to accompany enrollment; second payment of \$2000 due by December 15, 2011; third payment of \$2000 is due February 15, 2012, the fourth payment of \$2000 is due March 15, 2012. Balance due May 15, 2012.

DISMISSAL OF CAMPER: Parent fully understands and agrees that the Camp reserves the right to dismiss, in its sole discretion, any Camper whose condition, conduct, influence or behavior is deemed unsatisfactory or detrimental to the best interests of the Camp or his fellow campers or who violates camp rules and regulations. In the event of dismissal, tuition will be refunded on a pro-rated weekly basis minus the \$2000 registration deposit.

MEDICAL CARE: Medical care provided by the Camp Health Center is included in the tuition. Parent grants Camp permission to utilize medical treatment (including dental and orthodonture) outside of Camp should the Camp Director(s) deem such treatment necessary for the camper's well being. Should it be necessary for the well being of the camper to use outside medical care or if any special medications must be ordered, all expenses involved will be paid by Parent. In addition, any dental, orthodontic, or optical work will be paid by Parent.

CAMPER MEDICAL INFORMATION: Parent must inform the Director prior to registration if Camper has received professional counseling or medication for behavioral modification during the last 12 months. Parent must also inform Director immediately if such care or medication occurs after registration and prior to the camp season. Failure to so inform Director may lead to dismissal of Camper from Camp, and in the event of such dismissal, there will be no refund.

LATE ARRIVAL / EARLY DEPARTURE: No allowance or reduction will be made for late arrival or early departure of Camper without the Director's consent prior to the camp season. There will be an adjustment made if camper health requires an early departure from Camp.

PERMISSION TO PARTICIPATE: Parent grants camper permission to participate in all Camp programs and activities, excursions, and special outings and understands that accidents and injuries may occur in the natural course of participation in such activities. Parent understands that hikes and trips away from Camp are an integral part of the Camp program and gives permission to Camp Cedar to take Camper out of Camp to participate in these programs.

IMAGES, ETC: Permission is hereby given for Camp to use in promoting the Camp and in other ventures directly relating to the Camp (i) digital, photographic, video, and audio images or likenesses of camper; and (ii) statements, articles, names, music, art, photographs, audio recordings, films and videos created by Camper or originating from Camp or Camp-related activity.

BELONGINGS: Camp Cedar is not responsible for Camper's belongings or equipment while in transit or at Camp.

GRATUITIES: Tipping of staff, in any form, is prohibited.

COLLECTION: If tuition or fees are not paid in full for Camper, Parent will be liable for all costs of collection, including attorney's fees.

DISPUTES: All claims or disputes asserted by Camper or Parent against the Camp and arising from or related to this Agreement shall be brought and maintained in the courts of the State of Maine (County of Cumberland), and Parent expressly submits to the jurisdiction and venue of such courts. The substantive law of the State of Maine will govern such disputes without regard to conflict of law rules. Any individual bringing legal action against Camp, which action is denied in favor of Camp, will be responsible for all legal fees, court costs and out-of-pocket expenses of Camp, its owners and employees.
